Must provide the Port of Walla Walla seven (7) day advance notice on the proposed Date of Installation.

The above Applicant Name (hereinafter "Applicant") hereby requests the Port of Walla Walla (hereinafter "Port") to set a water hydrant meter/backflow device (hereinafter "Meter") at the above location for temporary water service pursuant to the following conditions:

Fees:

1. **Non-Refundable Application Fee:** Applicant will pay a **\$83.00 non-refundable application fee** to the Port which is due at the time of application. This fee covers the meter installation by the Port, account set up, and removal.
2. **Refundable Deposit Fee:** Applicant will pay an **\$880.00 refundable deposit** to the Port which is due at the time of application and will be refunded when the Meter is returned in good working order.
3. **Water Usage Fee:** The Applicant will pay a monthly billing fee of **\$1.00 per 100 cubic feet (748 gallons)** of water used to the Port. Failure to reimburse the Port for usage on a monthly basis will result in immediate removal of the Meter and termination of this Agreement.

Liabilities:

1. The Applicant assumes **full responsibility** for any and all damage to the Meter and/or the Port of Walla Walla's water distribution system caused by the abuse, vandalism, neglect, or misuse of the Meter. Costs associated with damage will be billed to the Applicant by the Port and could result in the denial of future use of a Port Meter.
2. The Port will secure the Meter to the hydrant via a lock and chain.
3. The Applicant is advised that if the temperature is forecasted to drop below freezing, the Applicant is responsible for winterizing the Meter.
4. DO NOT use the Meter hydrant valve as your flow control valve. Turn the Meter hydrant valve ON completely and use the Meter gate valve to control your water flow.
5. Port does not provide adapters or fill hoses for the Meter.
6. All roadways, shoulders and Meter shall be returned to their original conditions.
7. The Port reserves the right to shut down any Applicant's usage of the Meter if damaging or unsafe practices are being observed.
8. Altering, bypassing, and/or tampering with the Meter equipment is considered theft of service and is punishable by law and future use of the Port's water will be prohibited.
