Walla Walla Regional Airport (ALW) Emergency Contingency Plan – Tarmac Delay

Walla Walla Regional Airport has prepared this Tarmac Delay Contingency Plan pursuant to §42301 of the FAA Modernization and Reform Act of 2012. Walla Walla Regional Airport is filing this plan with the Department of Transportation because (1) it is a commercial airport or (2) this airport may be used by an air carrier described in USC 42301 (a)(1) for diversions.

This plan describes how, following excessive tarmac delays and to the extent practicable, Walla Walla Regional Airport will:

- Provide for the deplanement of passengers;
- Provide for the sharing of facilities and make gates available at the airport; and
- Provide a sterile area following excessive tarmac delays for passengers who have not yet cleared United States Customs & Border Protection (CBP)

ALW has facility constraints that limit our ability to accommodate diverted flights or maintain the airport's safe operation and strongly encourages aircraft operators to contact the airport at 509-525-3100 for prior coordination of diverted flights, except in the case of a declared in-flight emergency. Specific facility constraints include the following: lack of international passenger processing facilities, limited aircraft parking gates at the terminal for air carrier sterile operations, limited concessions through vending machines and airport is not staffed 24 hours per day,

Plan to Provide for the Deplanement of Passengers Following Excessive Tarmac Delays

ALW has limited equipment to include a turboway boarding ramp and personnel needed to safely deplane passengers from air carrier aircraft. ALW staff will utilize this equipment to deplane passengers as soon as practicable after receiving requests from such airlines at the contact number listed above. Staff will also provide contact information for Alaska/Horizon Airlines and Gorge Aviation FBO who may have the necessary equipment and personnel to safely deplane passengers as soon as practicable after receiving requests from such airlines experiencing excessive tarmac delays at the contact number listed above.

Plan to Provide for the Sharing of Facilities and Make Gates Available in an Emergency

Gate 2 at ALW is a common use gate to all carriers and is controlled by the airport. Additionally, Gate 1 at ALW is under preferential and/or exclusive leases to Alaska/Horizon Airlines and is not fully controlled by the airport. The sterile departure area at Walla Walla Regional will only accommodate approximately 80 persons. We will direct an air carrier seeking to deplane to our common use gate and make it available to the maximum extent practicable. If an additional gate is needed, we will coordinate with Alaska/Horizon Airlines to make their gate and other facilities available to an air carrier seeking to deplane at their gate during those time periods when the tenant airlines is not using, or not scheduled to use, the gate, to the maximum extent practicable.

<u>Plan to Provide a Sterile Area for Passengers Who Have Not Cleared United States</u> <u>Customs and Border Protection</u>

Walla Walla Regional Airport does not have international passenger processing facilities or local CBP officials. We will coordinate with law enforcement officials to identify suitable areas and procedures for establishing a temporary sterile area into which international passengers on diverted aircraft who have not yet cleared United States Customs and Border Protection can be deplaned. Once these efforts are complete, we will coordinate with local CBP officials to develop procedures that will allow international passengers who have not yet cleared United States Customs and Border Protection to be deplaned into these sterile areas to the extent practicable.
