## WALLA WALLA REGIONAL AIRPORT 2008 ACCOMPLISHMENTS

- ➤ Rehabilitated the south aviation ramp at a cost of \$1,882,446 with the FAA providing 95% funding and the airport provided 5% funding. Project included diamond grinding the concrete surface, repair/replace damaged concrete panels, joint sealing, stormwater drainage system and seal-coat refurbished concrete surface.
- Installed a Precision Approach Path Indicator (PAPI) system on Runway 20 at a cost of \$113,544 with the FAA providing 95% of funding and the airport provided 5% funding. System will enhance instrument landing capabilities.
- ➤ Installed new Enhanced Taxiway Centerline Markings at a cost of \$4,000. FAA provided 95% funding and the airport provided 5%.
- ➤ Building 206 @ 275 E. Aeronca Avenue re-roofed at a cost of \$30,065.
- ➤ Building 209 @ 301 E. Aeronca Avenue re-roofed at a cost of \$36,317.
- ➤ Building 210 @ 350 E. Beech Avenue re-roofed at a cost of \$30,065.
- ➤ Building 436 @ 150 W. Lear Avenue re-roofed at a cost of \$13,790.
- ➤ Building 910 @ 1320 F Street re-roofed at a cost of \$6,208.
- Constructed two additional wine incubator buildings at a cost of \$755,000. Port received a \$492,500 state capital appropriation and airport funded remainder of costs. Both buildings were leased upon completion to Cavu Cellars and Kontos Cellars.
- Entered into a 50 year land lease agreement with Mannina Cellars.
- > Contracted with Walla Walla County to chip seal A Street at a cost of \$12,000.
- Received a Transportation Security Administration Grant to offset a portion of the airport's Security Coordinator position.
- Received a grant from Washington State Department of Aviation to install a web camera on the terminal building at a cost of \$4,600.
- ➤ Six buildings received new fascia/trim and painting at a cost of \$6,000.
- Purchased a maintenance truck at a cost of \$31.655.
- > Purchased an administrative vehicle at a cost of \$22,300.
- Installed new lighting on the Horizon Airlines aviation ramp at a cost of \$3,905.
- Installed glass entryway doors at airport restaurant at a cost of \$17,480.
- > Commenced with airport terminal building recycling program.
- Purchased and installed a new parshall flume at a cost of \$2,751. Flume measures waste leaving airport to be treated by the City of Walla Walla.

- Installed two new overhead doors at the garage complex at a cost of \$1,853.
- > Purchased a Gravely mower at a cost of \$7,146.
- > Purchased a new TurboWay cover for the ADA passenger ramp at a cost of \$780.
- ➤ Installed new overhead door for Building 120 @ 102 W. Aeronca at a cost of \$3,530.
- ➤ Horizon Air commences Q-400 air service on October 27 and Port Commissioner Schneidmiller participates in Chamber of Commerce Air Coalition.
- > Successfully completed Part 139 certification inspection by the FAA.
